1815 Feb 2 On list of convicts disembarked from the "Marquis of Wellington" and forwarded to Windsor for distribution; listed as Aibry (Reel 6004; 4/3493 p.436)
1818 Petition for Ticket of Leave by William Aibrey, M Wellington 1815. On arrival assigned to Robert Film (?), then to William Cox Esq and now with Benjamin South, who endorsed the petition. (Fiche 3183; 4/1854 p.8)
1819 Apr 15 On list of prisoners sent to Newcastle per "Elizabeth Henrietta"; listed as Aibrey (Reel 6006; 4/3500 p.80)
1820 Jan 28 Runaway brought in by natives; listed as Wm Aubray (Reel 6067; 4/1807 p.75)

NSWGG 6 March 1833 p94. List of runaways apprehended. Aubrey, William, Marquis Wellington, from No.4 Road Party.
