Colonial Secretary's correspondence

20 July 1829 CSIL 29/5763 in 4/2040 from Princ Sup of Convicts to Col Sec. Have received a letter from James P Webber Patersons Plains requesting that the prisoners James Smith (Phoenix), Jno Shea (Borodino), Elias Suffolk (Bus Merchant) and Wm Andrews (Guildford) be assigned to him from the deceased William Clayton whose effects Mr Webber had administered. 22 July 1829 CSLS 4/3668 p455 [reel 1043]: the four men [see above] transferred to the service of James P Webber esq Patersons Plains.
