Colonial Secretary's correspondence

1819 Dec 30 On list of convicts disembarked from the "Recovery" and forwarded to Windsor for distribution – assigned to Mrs Baker at Windsor (CSLS 4/3501 p.145, reel 6007)
1821 Nov 7 On list of prisoners transported to Newcastle per "Sally" 7 November 1821 with a three year sentence by the Windsor Bench 12 October 1821 (Reel 6008; 4/3504A p.30)
1823 Feb; 1824 Dec On monthly returns of prisoners punished at Newcastle (Reel 6023; 4/1718 pp.163-4, 197) - details as follows: <i>NSW Colonial Secretary, Monthly Returns of Punishment, Newcastle 1810-25.</i> Feb 1823, 25 lashes, threatening to strike his overseer. Dec 1824, in service of JL Platt, 25 lashes for refusing to work at his master's farm.
1823 Sep 11 Convict servant of Mr Webber. To be victualled from the Store at Newcastle for six months (Reel 6011; 4/3509 p.230) – details as follows: request that Mr Webber and his six convict servants be victualled from His Ms Store at Newcastle for six months from 11 Sep 1823. The six were Stephen Hower (Mary 3), Jno Waggoner (Minerva), JD Cooper (Atlas), Rich'd Clarke (Providence),

1824 Feb 9 On monthly return of convicts assigned in the Counties of Northumberland and Durham; to Thomas Boardman (Reel 6028; 2/8283 p.77)
1824 Sep 11 On monthly return of convicts assigned in the Counties of Northumberland and Durham; to J L Platt (Reel 6028; 2/8283 p.93)

SR. Sydney Gaol Entrance Book 1819-1823, 4/6360 [reel 850]. John Benson, Recovery, admitted to Sydney Gaol 16 October 1821, committed by Windsor Bench, for three years at Newcastle.
 SR. Register of Convicts at Newcastle against whom complaint lodged, from 14 July 1818 [COD 120]. 1 Feb 1823, John Benson, riotous conduct. Sentenced to 2 months in Goal Gang.
 SR. Register of Convicts at Newcastle against whom complaint lodged, from 14 July 1818 [COD 120]. 4 Feb 1823, John Benson (Recovery), threatening to strike with an axe, sentenced to 25 lashes. (It was his overseer who was threatened – see Col Sec above).
 SR. Register of Convicts at Newcastle against whom complaint lodged, from 14 July 1818 [COD 120]. 18 November 1823, John Benson (Recovery), absenting himself from ***, sentenced to 50 lashes and Goal Gang.
 SR. Sydney Gaol Entrance Book 1825-1828, 4/6430 [reel 851]. John Benson, Prisoner [no ship stated] admitted 22 November 1826 [crime record is missing, as part of page is damaged], not guilty, disposed 30 November to P*** [unreadable].
 SR. Colonial Trials and Court Records, Benches of Magistrates, X821, 1827-28 [reel 660]. Sydney Bench, 3 Sept 1828, John Benson convicted of stealing corn in Government stables. Sentenced to 14 days treadmill and sent to a district road gang. [Note: no ship was given but there were only 2 John Benson convicts in NSW, the other arriving in 1797 with no mentions in Col Sec index for re-offences. Also, the 1828 Census shows John Benson (Recovery) in a road party.
 Wollongong University Archives, Wollongong Police Court/Bench of Magistrates records. 30 July 1834 John Benson, Recovery, assigned to John Reddall, attempting to sell tools he did not own, 50 lashes.
 Wollongong University Archives, Wollongong Police Court/Bench of Magistrates records. 16 May 1835 John Benson, Recovery, assigned to George Brown, absconding and assault, 6 months iron gang.
 NSW GG 5 April 1837 p291. Benson George, Recovery (1), 44, Poole, servant, 5' 8 qrt, dark sallow comp, dark flaxen hair, grey eyes, from G Brown Illawarra since March 24. [There is only one Benson on the Recovery (1), that is John Benson. The age and details given in the runaway notice match the indent details for John Benson and he was assigned to G Brown, Illawarra previous and subsequent to this].
