List of men married in New South Wales, who have not been before refused, and who are thus specially recommended to be allowed to proceed to Sydney instead of going to Van Diemens Land: Name: James Brownlee, Mangles. Sentence: Life to 10 years [colonial sentence] Where tried: Qr Ses Maitland. When tried: 10 Sep 38. Offence: Cattle stealing. Arrived: 5 Nov 38 [on Norfolk Island]. Remarks: Once before the Bench in Aug 1840. Theft. Good shepherd & butcher – generally steady.

Petition from Irish wife & others following his conviction for cow stealing (Ireland 1827) National Archives of Ireland. <i>Archives relating to the Transportation of Convicts from Ireland to Australia</i>. Document PPC 3186 [reel M2139]. Petition dated 5 September 1827 on behalf of James Brownlee, tried and imprisoned in Armagh for cow stealing and sentenced to transportation for seven years. Petition is signed by the Curate of Moy and six others. Petition states Brownlee has a wife and four small children and that it is his first offence. It says "We know him, his parents and family to be honest, just and sober residents in and about Portadown. There is a similar petition from his wife Catherine Brownlee filed with the above petition.</p> <p>2. Petition from colonial wife following his conviction for cattle stealing (Maitland NSW 1838) SR. CSIL 38/11654 in 4/4203.3, 1838 [reel 2211] Petition to Sir George Gipps The Respected Prayers of Julia Carey now Brownlee Free Most Humbly Sheweth That your Excellency's Petitioner having Emigrated to this Colony per ship David Scott in 1834 and became married to a James Brownlee (Free) by servitude in December of Same year with whom she had three young and helpless children and Pregnant of the Fourth. That Petitioner is reduced to the most calamitous circumstances arising from the conviction of her Husband James Brownlee at the General Quarter Sessions of the Peace holding at Maitland in September last and sentenced to transportation for Life for Cattle Stealing. That Petitioner not having the means of procuring for herself and destitute Family either Food or Garment since the conviction of her Husband nor future prospects, but depending on a Benign and Beneficent Community. Thus Reduced your Petitioner will humbly and Respectfully beg leave to appeal to your Excellency whom Providence has Blessed with power of doing good most earnestly, and [--?] imploring to take her distressful case and that of her young and helpless Children into consideration and be favourably pleased to mitigate the sentence of her Husband to any period that may seem meet to your Excellency so that they may [--?] hereafter for the mutual happiness and comfort. And your Excellency's Petitioner as in duty bound will ever pray Julia Carey now Brownlee Annotation: Impossible GG Oct 30"</p>
