Colonial Secretary's correspondence

<i>1825 Jan</i> On monthly return of prisoners punished at Newcastle, in the service of JP Webber, 100 lashes ordered by the Bench, Wallis Plains (50 for refusing work, 50 for false accusations against his master) (Reel 6023; 4/1718 p.199)
<i>1833 May 25</i> Philip Byrne tried at the last Campbelltown Quarter Sessions, committed by Major Antill from the Stone Quarry, charged with violent assault. (CSIL 33/3601 in 4/2176.1, Clerks of the Peace 1833). Note: ship not specified but the correct person confirmed by the Clerk of Peace records below:
<i>1833 May 9 &amp; 13</i> Clerk of Peace, Quarter Sessions Campbelltown (4/8387 p349+, reel 2400). Philip Byrne, Ann & Amelia, life, charged with aggravated assault, to be worked in an Iron Gang on the public roads for six months.

Admitted 11 August 1832 from HM Gaol for "evidence". Disposed to Hyde Park Barracks 15 August, behaviour in hulk "good".</p> <p>SR. Colonial Trials and Court Records, Benches of Magistrates 1831-33, Stonequarry (Picton) Bench Book, 4/7573 [reel 672]. Philip Byrne, Ann &amp; Amelia, life, charged with committing an aggravated assault, namely hitting a man in the eye with a bunch of files at Myrtle Creek, committed to trial at the Campbelltown Quarter Sessions. [for result, see Col Sec correspondence above].</p> <p>SR. Colonial Trials and Court Records, Benches of Magistrates 1832, Police Reports, Hyde Park Barracks, X825 [reel 661]. 14 May 1832. Phillip Byrne, Ann &amp; Amelia, life, in service of 41 Road Party, a runaway from his gang, a very troublesome character, 12 months in irons on the mountain roads.</p> <p>SR. Sydney &amp; Darlinghurst Entrance Books 1835-37, 4/6436 [reel 852]. Philip Burns, Ann &amp; Amelia 1825, bond, tried Dublin, Catholic, Cabinet Maker, admitted 16 December 1835 from Cox's River for examination. Transferred to Parramatta 18 August 1836.</p> <p>SR. **Note:** The NSW GG 5 March 1834 p123, list of prisoners apprehended includes "Byrne Philip per Ann and Amelia, [absconded] from escort to Roads". However the entry for what is probably the corresponding abscondment (NSW GG 19 February 1834 p92) is "Byrne Patrick, Ann & Amelia, 29, Dublin, Shoemaker, 5'6", fair pock-pitted comp, flaxen hair, grey eyes, from escort to No.3. Road Party, since Feb 12." Given the difference in occupation and height, this has not been entered into the datasheet above.
