Surgeon's report for the Hooghley shows that on 20 January 1825 Denis Carroll, aged 35, had scurvy as evidenced by spongy gums. He was treated by "prompt use of lemon acid" and cured by 5 February.</p> <p>National Archives of Ireland. <i>Archives relating to the Transportation of Convicts from Ireland to Australia</i>. FS 1828 1 [R101 M2225]. On list of applicants for their wives and families to be sent out to NSW at the expense of the Crown (list dated 9 October 1828). Wife, Julia Connors, and 4 children. The document carries the notation "1 May 1830" apparently added later, which may be the date of embarkation.</p>
