SG 9 June 1825 p4. Absconded from Edward Cory, Newcastle. [name, description and ship match indent]. Similarly, "Patrick Carr or Fitzpatrick, Asia (4)", absconded from Edward Cory, Newcastle 16 June 1825 [probably the same incident], in SR. Principal Superintendent of Convicts: List of Absconding Convicts and Assigned Servants 1822-25, 4/4525 [reel 587 & COD 241].

Note: The death of Patrick Carr on Norfolk Island in January 1832 is problematic despite it being clearly noted on his shipping indent. Either it is a large coincidence, or the entry has been confused with Matthew Carr (Asia, 1822) who also died on Norfolk Island in January 1832. Matthew's death appears in the convict death registers but Patrick's does not. Why the inconsistency for two convict deaths in the same establishment in the same month? *It is possible that Patrick Carr died at another time and/or in another place.*
