Casey, James or Thomas, Mariner [physical description matches indent exactly], absconded from Hyde Park Barracks. SG 19 March 1828 3d, repeated 26 March 1828 4a.

17 October 1828. Thos Casey, Mariner, life, in service of Government, neglect of work, 50 lashes. SR Returns of Trials, Newcastle Bench of Magistrates [COD 120].

NSW GG 12 July 1837 p504. Casey Thomas, Mariner (3), 27-691, 33, Sligo... impediment in speech, scrofula mark right side of neck... absconded from Australian Agricultural Company, Peel's River, since June 3.

NSW GG 19 July 1837 p520. Runaways apprehended. Casey Thomas, Mariner (3), Australian Agricultural Company, Peel's River.
