NANM 18/10/1834/3b: CQS. (14th) Life. Edward CHAUNTRY, age 21. Sentenced for a burglary on the house of George DRAYCOTT, of Watnall, and stealing wearing apparel.

NR 18/10/1834/3g: CQS. This gives slightly more detail of what exactly was stolen, and the fact that Edward pawned the items in Loughborough, but was arrested by a constable

in Mansfield. Mentions: Ann DRAYCOTT, Samuel MARK, Isaiah SHAW, William PEGG, William PALMER, Elizabeth DUFFIN, James GARTON, John FLEWITT, Charles WYKES, Richard RAGSDALE, Benjamin WRIGHT.

NR 19/12/1834/3f: Removed from the County Gaol on Friday last by E. B. BRIERLEY [who was the governor at the time], and assistants, and placed on board the *Ganymede* hulk at Woolwich, the following convicts: John WHITTAKER, William JARRATT, Edward CHAUNTRY, Thomas EVANS, and John MOUNTENAY to be transported for life. John JACKSON, for 14 years and to the *Fortitude* at Chatham, William HEATHCOTE, for 7yrs.
