Colonial Secretary's correspondence

<p>15 March 1838 CSIL 38/2717 in 4/2420.1, from Police Office, Paterson. James Caroline, Mangles 1828, holding TOL for this district, was committed by the Bench here 22nd last month for stabbing Alfred Cooper with intent to murder.</p> <p>17 December 1840 CSIL 40/12813 in 4/2505.7, from Police Magistrate, Dungog. [despatch contains the following letter from JD Walker to Thos Cook Esq, PM Dungog, as follows...] the following were present on 30th November when my house was robbed by four armed bushrangers... (long list including) two TOL holders: Alfred Cooper and John Lenon. 'These two men offered to follow me if I would command the attack in capturing them, but unfortunately had no fire arms, therefore I did not think it judicious or safe to commence'. 'I have no complaint to make against one of the men in my service as they only wanted my sanction to attack those robbers which I consider would be highly imprudent of me without</p>

fire arms to risk the lives of those men committed to my care also that which interested me most my wife and children'.

[The above was forwarded to the Col Sec with a covering note from the Police Magistrate at Dungog, with the following comment:

'if it please his Excellency to make an example it will... make the Prisoners and Ticket of Leave men interested in the Peace of the Colony, and Bushranging will speedily cease'.

[The Governor, George Gipps annotated the correspondence as follows:]

'Let the Tickets of Leave be cancelled of Alfred Cooper and John Lenon and let the undermentioned assigned servants be withdrawn [six of them] ... and the whole of them (including the Ticket of Leave holders) be sent to Pinchgut Island.'

(signed) G.G. Dec 25.

[note: the armed bushrangers were the Jewboy gang, and the incident took place at the Union Inn at Brookfield near Dungog. For further information see 'An Organised Banditti – the story behind the Jewboy Bushranger Gang' by Colin Roope and Patricia Gregson.]

NSW GG 3 June 1835 p394. Between October and December 1834 transferred from JP Webber to C&F Wilson [transferred convicts were listed by occupation rather than surname, enabling identification of some individuals. Cooper can be identified as the only 'mason's labourer' among the Tocal convicts].

SR, Newcastle Gaol Entrance Book 1841-45, 2/2008 [reel 756]. Alfred Cooper, Phoenix 1828, from Oxford, Protestant, labourer, #35 admitted to Newcastle Gaol 30 January 1841 for '2nd class gang on Pinchgut Island'. Disposed 'other stations, HM Gaol Sydney' 1 February 1841.

SR, Sydney and Darlinghurst Gaol Entrance Books 1839-1841, 4/6439 [reel 853]. Admitted (#220) 1 February 1841 from Dungog for 7 days Pinchgut Island. Disposed by interior to Pinchgut Island 3 February 1841.

SR, Sydney and Darlinghurst Gaol Entrance Books 1842-1844, 4/6440 [reel 854]. Admitted (#386) 2 March 1842 from Hyde Park Barracks for Probationary Gang Parramatta. Disposed via interior to Parramatta 4 March 1842.
