**27 March 1838.** (SR, Sydney Gaol Entrance Book 1837-1838, 4/6437 [reel 853]). Jas or Jno Creek admitted (#523) from Police for trial. Disposed to N Island 7 June 1838.  
 (SR Phoenix Hulk, Transportation Entrance Book, 18 Jan 1833 to 7 Sep 1848, 4/6445 [reel 820]). Jonah Creek, Phoenix 1828, original conviction Ipswich July 1827, Felony 7 years. Colonial conviction by Sydney Supreme Court 3 May 1838 for Highway Robbery. Sentence, death respited, decision by his Excellency the Governor, Norfolk Island. Forwarded 7 June 1838.
