- 14 Nov 1823 Davenport Jno [no ship stated], refusing work, 7 days cells
- 2 Dec 1823 Davenport Jno [**no ship stated**], neglect of work, 14 days cells There are two John Davenports the other John Davenport (Baring 1815, life) is not mentioned in various indexes such as Col Sec, TOL etc. Given that Tocal's John Davenport (Ocean 1823) is shown as assigned to Gov Newcastle in the 1823-25 Muster, the circumstantial evidence points to the above punishments referring to him, and they have been included in the analysis of secondary punishment of Tocal's convicts.

Letters to Benches of Magistrates & Justices of the Peace, November 1828 - September 1829, 4/3827 p198 [reel 2807]. 19 March 1829, to Bench of Magistrates Newcastle re their recommendation for Jno Davenport per Ocean to be appointed as constable at Newcastle. Same reference, same in-letters, p231, 2 April 1829 to the Superintendent of Police, Newcastle. The Governor does not think prisoners should be appointed as constable. [Davenport's T of L was gazetted on 3 March 1829, so it is not clear from this correspondence if his appointment as Constable was approved].
