"Peter Doyle or Michael Doyne, C ^{ess} Harcourt 1826", bond, from Dublin, RC, plasterer, admitted 29 September 1831 from Maitland, sentenced to three months in an iron gang, having been attached to 42 road Gang, disobedience of orders and general bad conduct. Forwarded to Sydney Gaol 11 October 1831. NSW GG 8 May 1833 p166. Doyle Michael, Countess of Harcourt, 27-939, 22, Plasterer's labourer, Dublin... absconded from No.6 Road Party since 17 th April.

Note: Great care needs to be taken when interpreting the records to distinguish two men on the Countess of Harcourt in 1827, namely:

DOWNES, Michael, tried in Dublin in 1826, life sentence, aged 20, carter, #27/923

DOYLE, Michael, tried in Dublin 1826, seven year sentence, aged 22, plasterer's labourer, #27/939 (the subject of this datasheet).

The corresponding entries in the 1828 Census of NSW for these two individuals are:

DOWN, Michael, 20, Countess of Harcourt 1827, life, Bathurst.

DOYNE, Michael, Countess of Harcourt, Road Gang 29.

The following entry in the Sydney Gazette on 16 June 1831 illustrates the problem: 'Doyne or Down, Michael, No. 27-923, Countess Harcourt, 22, carter, Dublin, 5 feet 5 ½, brown eyes, dark brown hair, ruddy pock-pitted complexion. Absconded from Road Gang 42'. He was apprehended soon after (SG 26 June 1831). It seems both men were in Road Gang 42 in 1831. Michael Downes was sent to Moreton Bay at some stage.
