10 January 1835	Governor of NSW approved Fee's request for free passage to NSW for his wife and two children. Their names to be included in the next list of persons recommended home for this indulgence. SR. CS 4/3680 p356 [reel 1048]. This information duplicated in CSIL 34/9068 [reel 2566].
20 August 1836	Dublin Castle. Fee's wife and children have declined the offer of a free passage to NSW. "She and her son have determined on not going – nothing said of a second child". CSIL 37/737 in 4/2359.2

SR, Clerk of Peace, depositions, T148 No.38 31/9.</p> <p>7 January 1831 admitted to the Phoenix Hulk from Hyde Park Barracks 1 January 1831 to give evidence in criminal proceedings Styles & others, returned 5 January 1831, behaviour in hulk "tolerable". SR Phoenix Hulk Entrance Book 1831-33, #49, 4/6282 [reel 819]. Similar entry in separate volume, reason given as "King versus Styles & others". In this entry Fee's original offence recorded as 'rebellion'. SR Phoenix Hulk Entrance Book 1825-1831, #3407, 4/6281 [reel 819].</p> <p>2 October 1834 petition for wife and two children for free passage to NSW, signed by Fee's employer, James P Webber [the three page petition appears to be written in Webber's hand, copy in file].
