CSLS (Letters addressed to Benches of Magistrates, Justices of the Peace and Superintendents of Police), 4/3829 p207 [reel 2808]. 10 November 1830 to P Aubin JP, Maitland [Police Magistrate] advising that His Excellency [Gov NSW] has approved the appointment of John Hanley as Constable.
CSLS (Letters addressed to Benches of Magistrates, Justices of the Peace and Superintendents of Police), 4/3831 p164 [reel 2809]. 13 January 1832 to P Anley esq re rates of pay for Police at Patersons Plains. Listed are John Hanley and James Sheal.
CSIL 34/010, 4/2252.2 Police Paterson 1834. Recommending John Handley, free, as constable. Approved 24 Jan 1834.
CSIL 35/3313, 4/2291.5 Police Paterson 1835. Hanley dismissed and another appointed in his place, 29 April 1835.
CSIL 36/820, 4/2331.3 Police Paterson 1836. Recommend appointment of John Handley, free, as constable.

Note: There was a John Henley on the Earl St Vincent 1820, life sentence . Great care is needed to distinguish between these two people in the records. John Hanley (Earl St Vincent 1823, 7 years) is confirmed as being first assigned to Edw Riley and then to JP Webber [Tocal] by the shipping indent for the Earl St Vincent 1823 and the exact matching physical description, age and occupation for “Handly John, Earl St Vincent” who absconded from JP Webber, Patersons Plains in 1827 (see ‘other’ below). Both the above entries for the 1823-25 muster contain errors, and both refer to John Hanley, Earl St Vincent 1823, who was assigned to Riley in 1823 and in turn to Webber in 1825.

Petition from John Hanley and another, tried Co Limerick, imprisoned Cork City, sentenced to transportation, document date 9/4/1823. To the Lieutenant General & General Governor of Ireland “... That these Petitioners state to your Excellency That on Trial no Charge of importance could be preferred against them, save that but being absent from their Dwelling houses, mostly Transacting their lawful business... hope & confidence that your Excellency will lend them part of your accustomed Clemency in restoring them to their forlorn families who are in that state of famine and will in the future be an incumbrance on the Counties unless your Excellency will take them into your human consideration...”</p> <p>SR. Sydney Gaol Entrance Book 1825-1828, 4/6430 [reel 851]. John Handley, Earl St Vincent, admitted 28 May 1827, committed by General Sessions Sydney. Runaway from his employment. Sentenced to an iron gang for 3 months, disposed 4 June to Parramatta.</p> <p>SG 26 Nov 1827 4c (repeated 3 Dec 1827 3f). On list on convicts who had absconded “Handly John, Earl St. Vincent, Shepherd, 25, County Limerick, 5 feet 4¾, grey eyes, dark brown hair, freckled comp. From J. P. Webber Esq. J.P. Patterson’s Plains”. Note: He absconded with John Hassett who was on the same ship and also at Tocal.</p> <p>SR, Letters to Benches of Magistrates, Justices of the Peace and Superintendents of Police, 30/802 in 4/3829 p207 [reel 2808]. 10 November 1830. John Hanley to be constable, will be notified in the next gazette.</p> <p>SR, Letters to Benches of Magistrates, Justices of the Peace and Superintendents of Police, 32/32 in 4/3831 p451 [reel 2809]. 13 January 1832, John Hanley, constable at Patersons Plains, free, to receive 2/3 per diem.</p> <p>NSWGG 29 January 1834 p56. Paterson: John Hanley, free, to be constable from the 9th instant, in the room of William Burke, dismissed for being drunk on duty.</p> <p>NSWGG 3 February 1836 p94. Paterson: John Hanley, free, to be constable from the 23rd Ultimo [January].</p> <p>NSWGG 8 February 1837 p170. John Hanley dismissed as constable, Paterson.</p>
