<b>T.O.L.</b>	45/703 Maitland, 26 March 1845, 4/4198 [reel 956]. Notations: "July 1848 6 months Irons. Pol Office. Maitland for Pilfering"; "Restored 51/110"; "C Pardon not prepared – his case to be brought under notice again should he become entitled to a Pardon under the Regulations applicable to his case. Col Sec letter 49/322 7 Sept 18**". TOL passport 46/777, 14 August 1846, 4/4263 [reel 975]. Allowed to remain in the service of Captain Pike at Darling Downs for 12 months, on recommendation of the Maitland Bench. TOL passport 47/179, 24 March 1847, 4/4265 [reel 976]. Allowed to remain at Liverpool Plains in the service of Mr Edwin Hickey for 12 months, on recommendation of the Maitland Bench. 51/110 Yass, May 1851, 4/4224 [reel 964]. Notations: "Cancelled on 28 June 1851 being unable to support himself"; "Restored 51/167". 51/167 Paterson, 12 August 1851, 4/4224 [reel 964]. Notations: "Surrendered, letter 54/91"; "Cancelled on 25 Janry 54 being unable from illness to support himself".

## Colonial Secretary's correspondence

<b>7 September 1849</b> , Sydney. CSLS to Principal Superintendent of Convicts, 4/3693 p308 [reel 1054]. John Linegar, Lord Lyndoch has misconducted himself since being recommended for a Conditional Pardon and the pardon will not be prepared. [Note: there is no John Linegar on any voyage of the Lord Lyndoch. The letter refers to William Lyndoch and this is confirmed by the notation on his first TOL as shown above].

## Other (source, details)

<p><b>31 August 1835.</b> SR. Punishment Book ("Black Book"), Patricks Plains 1833-39, 7/3714, page 36 [reel 689]. Linager William, L Lyndoch 33, life, employed by Mr James P Webber, a runaway, sent to Paterson to be dealt with. [Note: by this time Webber had sold Tocal and Munmurra Station and transferred his convicts. Those convicts working at Munmurra were transferred to the new owner, Captain William Henry Clarke. Evidently the Patrick Plains Bench, unaware of the change, thought Linegar had absconded from Webber at Tocal, and therefore sent Linegar to Paterson Bench to be sentenced. As per the entry below, once the mistake was realised he was escorted back to Patricks Plains and then to Merton, it being the closest Bench to Munmurra].</p> <p><b>22 September 1835.</b> SR, Merton Bench Book 1834-36, 4/5600 [reel 670]. William Linegar, Lord Lyndoch 1833 life, assigned to Mr Clarke, absconded five or six weeks ago, handed over from Patricks Plains 19 September 1835, guilty, 50 lashes.</p> <p><b>27 October 1835.</b> SR, Merton Bench Book 1834-36, 4/5600 [reel 670]. William Linegar, Lord Lyndoch 1833 life, assigned to Mr W Clarke, desertion second time, delivered by a Darlington constable, guilty, to serve 12 months to an Iron Gang and to be returned to his Master.</p> <p><b>28 October 1835</b> NSWGG p772. Runaway apprehended. Linegar William, Lord Lyndoch, from William Clarke, Patricks Plains.</p> <p><b>4 July 1848</b> Maitland Mercury 19 July 1848 p2. William Linegar brought Maitland Bench, charged with stealing oranges from the garden of John Eales (Linegar had previously been in Eales' service). To be deprived of his Ticket and worked six months in irons.</p> <p><b>27 July 1848.</b> Admitted to Darlinghurst Gaol from Maitland. #946, Wm Linegar, L Lyndoch 1833, TOL, for 6 months Iron Gang. Disposed to Cockatoo Island on 10 August 1848. SR, Sydney and Darlinghurst Gaol Entrance Books 1844-1849, 4/6441.</p>
